The White County Steering Committee A met on Monday, April 11, 2016 at the White County Courthouse. Members present were Stanley Neal, Karen Lafever, Diana Haston, Dale Bennett, Bruce Null, and Bruce Frasier. Also present were Chad Marcum, Marc Bilbrey, and Michael Hayes. Absent was Harold England

There being a quorum present, the meeting was called to order by Chairman Stanley Neal and prayer was led by Bruce Null.

Mr. Neal asked for approval of the minutes from the previous meeting. Karen Lafever made a motion and Dale Bennett seconded the motion to approve the minutes as presented. The motion was approved.

Report from Parks/Rec Advisory Board:

Discussion regarding Susan Barlow wanting money designated for Parks & Rec and possibly setting up a Booster Club/501(c)3 for fundraising. Chad Marcum advised on the risks of using a Booster Club for raising and handling money for Parks & Rec and the possibility to designate money directly through the county general fund. There was also discussion on sink holes at the county fields that need to be addressed.

Discussion on Closing Road during March 19th Baseball Tournament:

The White County Solid Waste Committee reconvened on Thursday, March 31st, 2016 at the White County Courthouse. Members present were Karen LaFever, Bruce Null, Terry Alley, Stanley Neal, Matt McBride and BK Luna. Also present were Keith McCulley, Chad Marcum, Denny Robinson and several visitors. Absent was Diana Haston.

There being a quorum present, the meeting was reconvened by Karen LaFever.

Ms. LaFever clarified the Solid Waste committee does not want to close the landfill. She went on to clarify that when the committee discussed closure, it was in regards to the current Class I cell for household garbage.

County Executive updated the committee on the current financial status of the landfill. He advised the committee on cost that will be incurred by the landfill regardless of how we proceed. These cost include the convenience center operational cost, closure of current cell, post closure cost, labor and equipment cost.

County Executive discussed cost associated with construction of a new cell and the continuation of current landfill operations as well as estimated cost associated with the construction and operation of a transfer station.

After a lengthy discussion, County Executive suggested transferring trash for a period of (5) five years. This will allow time for the county to develop and engineer a modern landfill design, giving the commission the opportunity to be proactive instead of reactive.

Stanley Neal made a motion and BK Luna seconded the motion to allow the County Executive to work with PES Engineering Firm on a transfer station, our current cell slope issue and landfill operations. All members voted in favor and motion was approved.

Landfill Director updated committee on equipment issues.

Discussion on Class III/IV waste collected at convenience centers and landfill. After a lengthy discussion, a motion was made to send to full court by Terry Alley and seconded by BK Luna that beginning July 1st, 2016 the County will stop receiving Class III/IV debris at convenience centers. Class III/IV waste will be collected only at the landfill. A tipping fee will be assessed to all Class III/IV debris/waste entering landfill based on weight. All members voted in favor of said motion. Motion was approved.

The White County Solid Waste Committee met on Monday, April 11th, 2016 immediately following Steering Committee B at the White County Courthouse. Members present were Karen LaFever, Bruce Null, Terry Alley, Stanley Neal, Matt McBride and Diana Haston. Also present were Keith McCulley, Cain Rogers, Russell Gooch, Bruce Frasier, Dale Bennett, Chad Marcum and Denny Robinson. Absent was BK Luna.

There being a quorum present, the meeting was called to order by Karen LaFever. Ms. LaFever asked for approval of the minutes from the previous meeting. Terry Alley made a motion and Matt McBride seconded the motion to approve the minutes as presented. The motion was approved.

Directors Report: Keith McCulley updated the committee on continued equipment issues. The landfill continues to have equipment issues on a weekly basis. Mr. McCulley states the Bomag Compactor continues to break down and was non-operational all last week. They have managed to get it running temporarily. In addition, both dozers were non-operational. Mr. McCulley states one dozer has been repaired and the other dozer needs a complete engine rebuild. However, based on the mechanical issues, age of the dozer, lack of maintenance over the past 10-15 years and current value, the dozer needs to be replaced.

After a lengthy discussion, Commissioner Alley made a motion and Bruce Null seconded the motion authorizing Solid Waste Director to purchase a bulldozer up to \$100,000.00 contingent upon proper procurement procedures.

On a roll call vote, Terry Alley – Yes, Stanley Neal – Yes, Matt McBride – Yes, Bruce Null – Yes, Diana Haston – Yes, Karen Lafever – Yes, BK Luna – Absent. Motion Approved.

Mr. McCulley updated committee on current status of the Class 1 cell. He states he has not heard from ECE engineers, we have not had any changes at this time and we are currently waiting on the state.

Chairman Lafever updated committee on status of contact from County Executive with PES Engineering Firm.

County Finance Director updated the committee on the progress with the RFP. We are making progress and Kim Raia, CTAS has been instrumental in the process.

Discussion on Convenience Center operations.

RESOLUTION 28-04-2016 To Establish Policy/Procedure For Solid Waste And Convenience Centers

WHEREAS; it is the duty of the County Commission to take all actions possible and necessary to efficiently provide certain services to the citizens of White County, and

WHEREAS; the disposal of solid waste and debris is a major concern to all residents and is an important factor to the economic development and continued growth of White County, and

WHEREAS; the County Commission must constantly monitor and adjust the operation of Solid Waste Department to ensure it is operating at maximum efficiency, thus guaranteeing the best service to White County with minimal associated cost to tax payers.

NOW THEREFOR BE IT RESOLVED; That the White County Commission meeting in a regular scheduled meeting, April 18, 2016, do hereby set forth the following policy/procedures for Solid Waste and Convenience Centers:

1. The user fee placed on electric bills provides White County Citizens the ability to dispose of household garbage only (class 1 waste).
 - A. Household garbage is defined as waste generated from normal day to day life in a personal dwelling. It does include appliances, furniture, computers, and TVs.
 - B. Household garbage is further defined as: If it is "used in" the house but not "attached to" the house it is considered household garbage.
2. All other debris/waste will be considered as construction debris (class 3/4) and will not be covered under the fee placed on the electric bills. A tipping fee will be charged to everyone, business or personal, disposing of this type of debris. Currently the tipping fee is \$41.25 per ton.
3. There will be no charge for any debris categorized as "recyclable."
4. Convenience Centers will no longer accept wood or construction debris (class 3/4). Only household garbage and recyclables will be accepted.

A. Furniture that is constructed of wood or has a wooden frame must be taken to landfill; but no tipping fee will be applied.

BE IT FUTHER RESOLVED; these policies/procedures shall take effect July 1, 2016 after passage by County Legislative Body, the public's health and wellbeing dependent on it.

Motion made by Bruce Null and seconded by Stanley Neal that the above resolution be adopted.

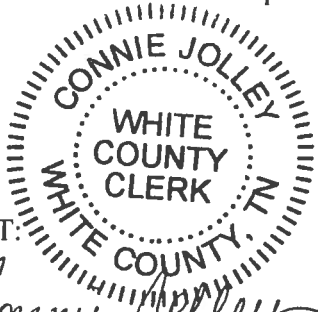

The White County Financial Management Committee met on Wednesday, April 6, 2016 at 5:00pm at the White County Courthouse. Members present were Mr. Clay Parker, Mr. Matt McBride, Mr. Cain Rogers, Ms. Diana Haston, and Mr. Russell Gooch. Also present was Mr. Chad Marcum. Absent was Mr. Denny Wayne Robinson and Ms. Sandra Crouch.

There being a quorum present, the meeting was called to order by Mr. McBride and a prayer was led by Mr. Marcum.

Mr. McBride asked for approval of the minutes from the January 6, 2016 meeting. Mr. Gooch made a motion and Mr. Parker seconded the motion to approve the minutes as presented. The motion was approved.

Mr. Marcum addressed the committee regarding finance department operations, including sales tax collections, EMS collections, and an IRS examination of White County's Series 2008 bond issue in the amount of \$5,120,000. The bond issue was randomly selected by the IRS to assure compliance with regulations and to determine if the bond proceeds were being used for governmental purposes. Mr. Marcum indicated that there should be no issues with the examination and that the interest received by the bondholders should remain exempt from federal taxation.

Mr. McBride asked the committee for any old business – there was none.

Mr. McBride asked the committee for any new business:

The committee considered a resolution authorizing the write-off of \$19,094.06 in bad debts for the White County Solid Waste Department for compliance with TCA 28-3-304. After discussion, Mr. Rogers made a motion and Ms. Haston seconded the motion to approve the requested write-off. The motion was approved.

The committee considered a request to begin the process of selling two parcels of property (lots 21 and 22) on Flatt Street, which were acquired by the county in a delinquent tax. Mr. Frank Nash of Sparta has shown interest in acquiring the parcels for the statutorily required amount of \$3,102.56, which covers all back taxes, interest and penalty, and fees. Mr. Rogers made a motion and Mr. Parker seconded the motion to approve moving forward with the sale process. The motion was approved.

The committee considered a resolution to request the unclaimed balance of accounts remitted to the state treasurer under the unclaimed property act by White County and its agencies. Mr. Gooch made a motion and Ms. Haston seconded the motion to approve the resolution as presented. The motion was approved.

RESOLUTION TO DISPOSE OF UNCOLLECTABLE SOLID WASTE ACCOUNTS

WHEREAS, the Legislative Body of White County did, while meeting in regular session on May 18, 2015, approve Resolution 38-05-2015 establishing certain policies and procedures for accounts receivable to be written-off, AND

WHEREAS, the established write-off procedures require the approval of the county legislative body, the County Executive, and the Director of Finance for any account balance greater than or equal to one thousand dollars (\$1,000) before being written-off, AND

WHEREAS, the County Executive and Director of Finance are in agreement as to the uncollectability of certain solid waste accounts greater than or equal to one thousand dollars (\$1,000), AND

WHEREAS, the Department of Finance, acting as debt collector, believes it to be in the best interest of White County to dispose of said accounts through a write-off procedure, AND

WHEREAS, TCA §28-3-304 states that a municipality shall not collect solid waste amounts owed as a result of nonpayment that are more than thirty-six (36) months past the date payment was first due.

IT IS THEREFORE RESOLVED, that the five solid waste accounts, hereto attached by reference and itemized on the White County Department of Finance Account Write-off Approval Form, totaling nineteen thousand, ninety-four dollars and six cents (\$19,094.06) are hereby written-off as bad debts of White County, Tennessee.

RESOLUTION TO REQUEST UNCLAIMED BALANCE OF ACCOUNTS REMITTED TO STATE TREASURER UNDER UNCLAIMED PROPERTY ACT

WHEREAS, Tennessee Code Annotated Section 66-29-102 and Section 66-29-123, as amended by Public Chapter 401, Acts of 1985, provide that a municipality or county in Tennessee may request payment for the unclaimed balance of funds reported and remitted by or on behalf of the local government and its agencies if it exceeds \$100, less a proportionate share of the cost to administer the program; AND

WHEREAS, White County or its agencies have remitted unclaimed accounts to the State Treasurer in accordance with the Uniform Disposition of Unclaimed Property Act, AND

WHEREAS, White County agrees to meet all of the requirements of TCA Section 66-29-101 et seq., to accept liability for future claims against accounts represented in funds paid to it, and to submit an annual report of claims received on these accounts to the State Treasurer by September 1 each year, AND

WHEREAS, it is agreed that this local government will retain a sufficient amount to insure prompt payment of allowed claims without deduction for administrative costs or service charges and that the balance of funds will be deposited in this local government's general fund.

IT IS THEREFORE RESOLVED, that the legislative body of White County requests the State Treasurer to pay the unclaimed balance of funds to it in accordance with the provisions of Tennessee Code Annotated Section 66-29-121.
