The White County Steering Committee A met on Monday, April 5th, 2021, at the White County Courthouse. **Members of Committee A include Commissioners Lanny Selby, Chairman, Dillard Quick, Cain Rogers, Terry Alley, Lonnie Crouch, and Lee Broyles.**

Chairman Selby called the meeting to order and requested roll call. Members present include, Chairman Lanny Selby, Dillard Quick, Cain Rogers, and Lonnie Crouch. Absent were Commissioners Terry Alley and Lee Broyles. Also present were County Executive, Denny W. Robinson, Solid Waste Director Gaylen Barlow, and Finance Director Chad Marcum. There being a quorum, the meeting continued with opening prayer led by Commissioner Lonnie Crouch.

Chairman Selby asked for review and approval of the Minutes from the February 4th, 2021 meeting. With no discussion, Commissioner Rogers made a motion and Commissioner Crouch seconded the motion to approve the Minutes as presented. With no objections the motion was approved.

Chairman Selby open the floor by requesting an update from the Parks and Rec Sub-Committee, Commissioner Mason stated that the Parks & Rec committee are in the process of working on the county owned basketball courts at the high school such as ordering new rims and refurbishing the backboards, bad fencing had been replaced. He also stated that there had been two permanent trash receptacles placed at the ball courts and tennis court, those were sponsored by the litter grant. Mason stated that the renter at the old middle school is offering his services to help repair the buckled floor. This completed his update from Parks & Rec.

Chairman Selby open the floor for the next item on the agenda, Mr. Alex Callis from Tennessee Tech University addressed the committee with interest in helping get a disc golf course added to the Highway 70 Recreational Complex. He shared that the cost of the course might cost 10-15 thousand but after the cost to build there would be no upkeep other than mowing. Commissioner Selby suggested that Mr. Callis attend the Parks & Rec sub-committee the following week to discuss the course with those members. However, Executive Robinson recommended that Mr. Callis visit the site to see if it meets the requirements for a disc golf course and if so then Mr. Callis could then speak to the Parks & Rec Committee about adding this course to the facility. Chairman Selby, Commissioner Mason, Executive Robinson, and Alex Callis all agreed to meet at the facility the following Friday.

Old Business: Commissioner Quick asked for an update on the pavilion at the Mitchell's Ford Kayak Launch and how much of the grant we had left to spend on the project. Executive Robinson stated that the pavilion is up and there is an estimated 40, 000 remaining from the grant to be spent on this project. Commissioner Austin asked if there was a way to add a concrete launch ramp for in/out access for the kayaks. Executive Robinson stated that they could go to Mitchell's Ford and take a look to see if it was something that could be added.

Commissioner Rogers asked if the July 4th fireworks show is still happening and Executive Robinson confirmed that the show will still take place.

Commissioner Mason advised the committee that he was taking the Pointe Lane plat to the planning commission to see if they were familiar with what happened to this lane being a county road.

New Business: There was no new business.

With no further discussion or business, Chairman Selby announced that the White Co. Legislative Body will meet in regular session on Monday, April 19th, 2021 at 6pm.

White County Steering Committee B met on Monday, April 5, 2021 at the White County Courthouse. **Members of Committee B include White County Commissioners Robert McCormick, Chairman, Andy Haston, Vice Chairman, Dakota White, Secretary, Stanley Neal, Roger Mason, T.K. Austin, and Robert (Dale) Bennett.**

Members present were Commissioners Dakota White, Stanley Neal, Roger Mason, T.K. Austin, Robert McCormick, Andy Haston, Dale Bennett and Executive Denny Wayne Robinson. None absent. Also in attendance were White County residents, Ms. Debra McIntyre, Paul Smalley, John Ford, Chris Brewington and two others not identified.

There being a quorum present, Chairman Robert McCormick called the meeting to order at 5:30pm. Prayer was led by Commissioner White.

Chairman McCormick requested review and discussion of the March 1, 2021st Committee B meeting Report. Commissioner Austin made a motion to approve the Report as presented, seconded by Commissioner Haston; none opposed, and motion was approved.

Executive Robinson addressed members about the request to surplus a E-1 Pumper #903 from Eastland Fire Dept. Executive Robinson explained that the E-1 Pumper #903 truck was purchased by the county approximately ten -twelve years ago and is no longer operational. Fire Dept. officials will access the truck and will remove any parts and/or equipment that could be used in the future. Executive Robinson further stated that a grant was recently submitted and if awarded, Eastland Fire Dept. would receive a new tanker fire truck. Commissioner White made a motion to move the Resolution to *Dispose of Surplus E-1 Pumper (#903)* to full court for consideration and final approval; the motion was seconded by Commissioner Haston, with no further discussion and none opposed, the motion was approved by Committee B.

Further business brought before Committee B included the need for an updated Occupational Health and Safety Plan for White County. Executive Robinson presented a drafted Resolution to *Establish Updated Occupational Safety and Health Program Plan* for consideration. Executive Robinson stated that state law (1973) requires counties to have an updated plan to meet the current T.C.A. Code. The Resolution would amend the county's outdated plan and then meet requirements set forth by the state. With no additional discussion, Commissioner White made a motion to move the Resolution to *Establish Updated Occupational Safety and Health Program Plan* to full court for consideration and final approval; the motion was, seconded by Commissioner Neal with no further discussion and none opposed, the motion was approved by Committee B.

Old Business:

Chairman McCormick opened the floor for any old business. No matters were brought by committee members. Chairman McCormick opened the floor for questions, comments or discussion from citizens in attendance. Ms. Debra McIntyre requested an update on the Health & Safety Codes Resolution that was passed in 2020. Executive Robinson stated that the process has ceased due to the lack of support from the General Assembly. Executive Robinson further explained that moving forward would be a waste of revenue without an amendment to the current state law that would amend T.C.A. Codes for sufficient enforcement and allowing equal enforcement measures to be taken when a property owner or renter violated county code(s). Commissioner Mason further stated that the Resolution that passed by the White County Legislative Body in 2020 was still in effect, however, without proper enforcement options, efforts to proceed would be useless. Commissioner Mason stated that the Resolution would have to pass by two-thirds vote in a regular session held by the White County Legislative Body in order to amend or nullify the Resolution.

New Business: There was none.

With no further questions or comments from attendees, Chairman McCormick announced upcoming meetings for the White County Board of Commissioners.

The White County Solid Waste committee met Monday, April 5th, 2021 at the White County Courthouse. **Members of Solid Waste Committee are Commissioners Dillard Quick, Chairman, Andy Haston, T.K. Austin, Lanny Selby, Stanley Neal, and Robert McCormick.**

Chairman Quick requested roll call of committee members. Present were Commissioners Dillard Quick, Stanley Neal, Lanny Selby, Andy Haston, Robert McCormick and T.K. Austin. Absent was Commissioner Lee Broyles. Also present was County Executive, Denny W. Robinson, and Gaylen Barlow, Solid Waste Director. There being a quorum, the meeting was called to order.

Chairman Quick opened the floor by requesting review, discussion, and approval of the Minutes from the February 1st, 2021 meeting. With no discussion, Commissioner Selby made a motion and Commissioner Haston seconded the motion to approve the Minutes as presented. With no objections the motion was approved.

Chairman Quick requested the Directors report from Solid Waste Director, Gaylen Barlow. Barlow stated that he had some randomly picked dates with the total amount of tonnage of garbage taken in at the Landfill. On March 18, 2021, 374.62 ton was collected, March 24, 2021, 339.54 tons of was collected, and then on March 30, 2021, 374.62 ton was collected and Barlow stated to the best of his knowledge that broke a record for most garbage collected in one day for White County. Barlow shared with the committee that the transmission seal and went out on the articular truck and it is being repaired with an estimated cost of \$30,000. This concluded his report.

Executive Robinson reviewed the Engineers report from TriAd with members Below is an update on where we stand regarding the ongoing items at the White County Landfill. TriAD is putting together the Annual Engineering Report that is due to TDEC by May 1st, including the estimate of remaining landfill life (based on the March 1st survey by Vick Surveying). In regards to Class I Landfill Expansion Hydrogeologic Investigation; TriAD has completed monitoring of the newly installed piezometers within the proposed Class I landfill expansion area. The data supports the original potentiometric surface and demonstrates that the uppermost aquifer is not immediately below the ground surface as presented by Mr. Doug Brady with TDEC. TriAD will submit the results of the additional hydrogeologic investigation on Friday, April 9th. They have been coordinating additional investigation activities, including timeline for resubmittal, with Mr. Nick Stengel, the TDEC Cookeville Field Office Manager. He previously advised that the investigation extend through the end of March to ensure we had sufficient data. TriAD submitted the revised Class III/IV Landfill vertical expansion application documents for field office review on January 25th. Per Doug Hatfield, the Cookeville Field Office engineer, the Cookeville Field Office has no additional comments and is in the process of scheduling the final review with the Central Office for approval. Per Nick Stengel, and in response to our email regarding Doug Brady's request to resample PZ-102B, White County will not be required to resample PZ-102B. While the rising chlorides in PZ-

102B are statistically significant, the concentrations are still very low. We will continue to monitor them during our regularly scheduled semi-annual groundwater monitoring events.

In further discussion Executive Robinson stated that if all there were no objections, he would like to get the Doyle Convenient Center moved across the road as this would make a much safer option for the community and employees.

Chairman Quick opened the floor to Lisa Luck, by phone. Lisa stated that the purpose of the report, is that all counties are required to submit this report by law to the State of Tennessee to ensure that all counties are providing solid waste services for their residents. Lisa shared for the 10-Year Plan report that White County got a vertical expansion for Class I Landfill and are working to get a Class III/IV vertical expansion. The III/IV has been approved and work will begin in 2021. White County has plenty of disposal space that will last a number of years. There is also room to expand the landfill as needed. White County continues to seek out ways to recycle. They will begin collecting and baling cardboard in 2021. The Annual Progress report went as follows: White County continues to manage waste through a series of convenience centers. Residents bring solid waste and recyclables to the convenience centers. City of Sparta continues to utilize the White County Landfills to manage their waste, as does Doyle. In 2020, the county reported recycling 524.06 tons of materials plus 207.68 tons of tires for a total of 731.74 tons. Comparison to 2019: Recycling 401.34 tons, plus 440.73 tons of tires for a total of 842.07. In 2020, TDEC reported that 15,997.26 tons of waste went into Class I Landfills from White County. TDEC reported 10,667.54 tons went into Class III/IV landfills. In 2019, TDEC reported 17,292.25 tons of solid waste went into a Class I Landfill. Less waste went into the Class I Landfill in 2020 than in 2019. Commercial RRs: Walmart (808.78 tons), Jackson Kayak (94.08), THK Rhythm (1230.78), Valley Proteins (141.23), Dollar General (178.1), Serenity Pointe (166), Global Recycling (9.94), Cooper Recycling (669.18) and Funderburks (26.5) for a total of 3,325.59 tons recycled by businesses. The State of Tennessee requires White County to show that 25% or more percent of the solid waste was diverted from a Class I Landfill. Diversion Rate (Commercial RR reports + county report + Class III = diversion): Approximately 48%. Executive Robinson asked Lisa why there was conflicting numbers between the Landfill's report and TDEC's report. Luck stated that she would be in contact with TDEC to see if they had finished entering the solid waste numbers for White County. She stated that there is nothing for the county to do that it is up to TDEC to reassess if the numbers were incorrect at the conclusion of TDEC's final reporting. Luck concluded her report. Commissioner Robert McCormick made a motion to approve the APR, seconded by Lanny Selby, with none opposed, the motion was approved.

Old Business: There was no old business brought to the committee for discussion.

New Business: There was no new business brought to the committee for discussion.

With no other announcements or business, Chairman Quick announced that the White Co. Legislative Body will meet in regular session on Monday, April 19th, 2021 at 6pm.

The White County Budget Committee met on Monday, April 5, 2021 following the Solid Waste Committee at the White County Courthouse. Members present were Mr. Stanley Neal, Mr. Roger Mason, Mr. Cain Rogers, Mr. Andy Haston, and Mr. Denny Wayne Robinson. Also present were Mr. Chad Marcum, Mr. Dakota White, Mr. TK Austin, Sheriff Steve Page, Mr. Kenny Dobson, Mr. Chris Brewington, and Ms. Rachel Auberger of the Expositor.

There being a quorum present, the meeting was called to order by Mr. Robinson.

Mr. Robinson asked for approval of the minutes from the March 17, 2021 meeting. Mr. Haston made a motion and Mr. Neal seconded the motion to approve the minutes as presented. On a voice vote, the motion was unanimously approved.

The committee considered a General Fund budget amendment in the amount of \$6,479 to reallocate funding from an unfilled night clerk position to other positions in the Sheriff's Department and the Jail in order to give key employees of the department raises. Mr. Robinson expressed his thoughts that this would be best handled through the normal upcoming fiscal year budgetary process. Mr. Robinson asked for a motion on the amendment, but received none. Receiving no motion, the amendment failed.

The committee considered a General Purpose School Fund budget amendment in the amount of \$500,000 to authorize the transfer of funds from the General Purpose School Fund to the School Federal Projects Fund for cash flow purposes. Mr. Mason made a motion and Mr. Rogers seconded the motion to approve the budget amendment as presented, contingent upon school board approval, and recommend its passage by the full county commission. On a voice vote, the motion was unanimously approved.

The committee considered a General Purpose School Fund line item amendment in the amount of \$15,000 to reallocate funds within the Transportation category for the purchase of radios and equipment for school buses. Mr. Mason made a motion and Mr. Neal seconded the motion to approve the amendment, contingent upon school board approval. On a voice vote, the motion was unanimously approved.

The committee considered six (6) School Federal Projects Fund budget amendments as follows:

1. Subfund 801 – CTE Perkins Basic: \$5,165.45
2. Subfund 931 – ESSER 1.0: \$67,121.52
3. Subfund 933 – ESSER 2.0: \$90,000.00
4. Subfund 102 – Title I, Part A: \$2,935.00
5. Subfund 201 – Title II: \$11,460.00
6. Subfund 411 – Title IV: \$925.00

Mr. Neal made a motion and Mr. Haston seconded the motion to approve the budget amendments as presented, contingent upon school board approval. On a voice vote, the motion was unanimously approved.

The White County Budget Committee met on Monday, April 12, 2021 at 5:00pm at the White County Courthouse. Members present were Mr. Roger Mason, Mr. Cain Rogers, Mr. Andy Haston, and Mr. Denny Wayne Robinson. Also present were Mr. Chad Marcum, Mr. Dakota White, Mr. Chris Brewington, Mr. Kyle Goff, Mr. Zach Buckner, and Ms. Connie Davis.

There being a quorum present, the meeting was called to order by Mr. Robinson.

Mr. Robinson asked for approval of the minutes from the April 5, 2021 meeting. Mr. Rogers made a motion and Mr. Haston seconded the motion to approve the minutes as presented. On a voice vote, the motion was unanimously approved.

The committee reopened discussions regarding the Fiscal Year 2022 County General Fund budget. Mr. Robinson introduced Mr. Zach Buckner representing WCTE – Central Tennessee PBS. Mr. Buckner stated that WCTE had recently developed a partnership program that pairs their creative marketing team with local governments in their viewing area to help promote tourism and economic development. Mr. Buckner stated that for a \$10,000 donation to WCTE, the county would be provided multiple marketing and promotional materials and opportunities. Mr. Robinson stated his support for the measure to be included in the FY 2022 budget, and recommended that the local Hotel/Motel tax revenues be used to cover the costs since they are designated for tourism. However, it was discussed that the full amount might not be able to come from tourism dollars and that perhaps a lower amount could be contributed. Mr. Buckner thanked the committee for their consideration. No formal action was taken.

Mr. Marcum presented a prospective listing of non-profit contributions for the 2022 fiscal year. The committee received requests from three organizations to be added to the list, including Seeds of Hope of TN, White County Humane Society – spay and neuter grant, and WCTE – Central Tennessee PBS. The committee discussed the three requested additions as well as the existing list. No formal action was taken.

Mr. Robinson addressed the committee regarding the inclusion of funding for a building codes inspector for White County. Currently that task is handled by the State of Tennessee, which also receives all of the permit application fees. 

RESOLUTION NO. 20-04-2021

RESOLUTION TO ESTABLISH AN UPDATED OCCUPATIONAL SAFETY AND HEALTH PROGRAM PLAN, DEVISE RULES AND REGULATIONS, AND TO PROVIDE FOR A SAFETY DIRECTOR AND THE IMPLEMENTATION OF SUCH PROGRAM PLAN

WHEREAS, in compliance with Public Chapter 561 of the General Assembly of the State of Tennessee for the year 1972, the White County Legislative Body hereby updates the Occupational Safety and Health Program Plan for our employees.

WHEREAS, due to various changes in subsequent years, it has become necessary to amend the program plan to comply with more recent state requirements.

NOW, THEREFORE, BE IT RESOLVED, by the White County Legislative Body that the Occupational Safety and Health Program Plan be amended as follows

TITLE:

This section shall be known as "The Occupational Safety and Health Program Plan" for the employees of White County, Tennessee.

PURPOSE:

The White County Legislative Body in electing to update the established Program Plan will maintain an effective and comprehensive Occupational Safety and Health Program Plan for its employees and shall:

- 1) Provide a safe and healthful place and condition of employment that includes:
 - a) Top Management Commitment and Employee Involvement;
 - b) Continually analyze the worksite to identify all hazards and potential hazards;
 - c) Develop and maintain methods for preventing or controlling the existing or potential hazards; and
 - d) Train managers, supervisors, and employees to understand and deal with worksite hazards.
- 2) Acquire, maintain and require the use of safety equipment, personal protective equipment and devices reasonably necessary to protect employees.
- 3) Record, keep, preserve, and make available to the Commissioner of Labor and Workforce Development, or persons within the Department of Labor and Workforce Development to whom such responsibilities have been delegated, adequate records of all occupational accidents and illnesses and personal injuries for proper evaluation and necessary corrective action as required.

- 4) Consult with the Commissioner of Labor and Workforce Development with regard to the adequacy of the form and content of records.
- 5) Consult with the Commissioner of Labor and Workforce Development, as appropriate, regarding safety and health problems which are considered to be unusual or peculiar and are such that they cannot be achieved under a standard promulgated by the State.
- 6) Provide reasonable opportunity for the participation of employees in the effectuation of the objectives of this Program Plan, including the opportunity to make anonymous complaints concerning conditions or practices injurious to employee safety and health.
- 7) Provide for education and training of personnel for the fair and efficient administration of occupational safety and health standards, and provide for education and notification of all employees of the existence of this Program Plan.

COVERAGE:

The provisions of the Occupational Safety and Health Program Plan for the employees of White County, Tennessee shall apply to all employees of each administrative department, commission, board, division, or other agency whether part-time or full-time, seasonal or permanent.

STANDARDS AUTHORIZED:

The Occupational Safety and Health standards adopted by the White County Legislative Body are the same as, but not limited to, the State of Tennessee Occupational Safety and Health Standards promulgated, or which may be promulgated, in accordance with Section 6 of the Tennessee Occupational Safety and Health Act of 1972 (T.C.A. Title 50, Chapter 3).

VARIANCES FROM STANDARDS AUTHORIZED:

Upon written application to the Commissioner of Labor and Workforce Development of the State of Tennessee, we may request an order granting a temporary variance from any approved standards. Applications for variances shall be in accordance with Rules of Tennessee Department of Labor and Workforce Development Occupational Safety and Health, VARIANCES FROM OCCUPATIONAL SAFETY AND HEALTH STANDARDS, CHAPTER 0800-01-02, as authorized by T.C.A., Title 50. Prior to requesting such temporary variance, we will notify or serve notice to our employees, their designated representatives, or interested parties and present them with an opportunity for a hearing. The posting of notice on the main bulletin board shall be deemed sufficient notice to employees.

ADMINISTRATION:

For the purposes of this resolution, Jennifer Rigsby, Human Resources Director is designated as the Safety Director of Occupational Safety and Health to perform duties and to exercise powers assigned to plan, develop, and administer this Program Plan. The Safety Director shall develop a plan of operation for the Program Plan in accordance with Rules of Tennessee Department of Labor and Workforce Development Occupational Safety and Health, SAFETY AND HEALTH PROVISIONS FOR THE PUBLIC SECTOR, CHAPTER 0800-01-05, as authorized by T.C.A., Title 50.

FUNDING THE PROGRAM PLAN:

Sufficient funds for administering and staffing the Program Plan pursuant to this resolution shall be made available as authorized by the White County Legislative Body.

BE IT FURTHER RESOLVED, that if any section, sub-section, sentence, clause, phrase, or portion of this resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

This resolution shall take effect from and after the date it shall have been passed, properly signed, certified, and has met all other legal requirements, and as otherwise provided by law, the general welfare of the County requiring it. Complete and amended Occupational Safety and Health Program Plan attached here unto.



 - B. Enter into the necessary agreements with the Tennessee Housing Development Agency to receive and administer said program funds.
 - C. Execute necessary agreements for Administrative services without further action by the County Commission, contingent upon approval by the funding agencies.
2. The Upper Cumberland Development District shall prepare all necessary documents for the completion of said application for the proposed project at no charge to White County. Should said HOME application be approved, UCDD shall be engaged to perform all administrative services for said project.
