The White County Steering Committee A met on Monday, October 4, 2021, at the White County Courthouse. Members of Committee A, for 2022/2023 include, White County Commissioners Cain Rogers, Lanny Selby, Larry Daniels, T.K. Austin, Thomas Margeson, Becky Golden and Derrick Hutchings.

Agenda item #1 - #3 -Call to Order – Roll Call – Prayer:

Executive Robinson called the meeting of Steering A to order and requested roll call of members present. K. England, Recorder called the roll of members in attendance. Members present were Commissioners Larry Daniels, Becky Golden, Derrick Hutchings, and Thomas Margeson.

Recorded as absent were Commissioners T.K. Austin (called in) and Lanny Selby.

Also present were Executive Robinson and several White Co. citizens

There being a quorum present, Executive Robinson welcomed everyone and opened with prayer.

Agenda item # 4 – Approval of Minutes from August 1, 2022, Steering A meeting

Executive Robinson asked for review and approval of the Report from the August 1, 2022, Steering A meeting. Commissioner Hutchings made a motion to approve the Report as presented, the motion was seconded by Commissioner Larry Daniels, without opposition, the motion was approved by all members.

Election of 2022-2023 Steering Committee A Officers

- **Agenda item #5 - Appointment for Chairman of Committee A**

Executive Robinson opened the floor for nominations for Chairman of Steering Committee A for the 2022/2023 term. Commissioner Daniels nominated Commissioner Austin to serve as Chairman. No other nominations were presented, Commissioner Golden made a motion that all nominations cease, and that Commissioner Austin be appointed Chairman of Steering Committee A by acclamation, motion was seconded by Commissioner Margeson, with none opposed the motion was approved by all members.

- **Agenda item # 6 Appointment of Vice Chairman**

Executive Robinson opened the floor for nominations for Vice Chairman of Steering Committee A for the 2022/2023 term. Commissioner Daniels nominated Commissioner Hutchings to serve as Vice Chairman. No other nominations were presented, Commissioner Golden made a motion that all nominations cease, and that Commissioner Hutchings be appointed Vice Chairman by acclamation, motion was seconded by Commissioner Margeson, with none opposed the motion was approved by all members.

- **Agenda item # 7 Appointment of Secretary**

In the absence of Chairman Austin, Executive Robinson turned the meeting over to Vice Chairman Hutchings. Hutchings opened the floor for nominations for Secretary of Steering Committee A for the 2022/2023 term. Commissioner Margeson nominated Commissioner Golden to serve as Secretary of

Steering Committee A. No other nominations were presented. Commissioner Hutchings made a motion that all nominations cease, and that Commissioner Golden be appointed Secretary by acclamation. The motion was seconded by Commissioner Daniels, with none opposed the motion was approved by all members.

Agenda item #8 – Reimbursement to YMCA

The YMCA requested reimbursement for payment they made for a downed power pole and electrical lines at the county owned Doyle Softball field. An invoice for \$2,000 from Griffin Electric was presented. After brief discussion, Executive Robinson explained that if reimbursement was approved, the funds would come from the Parks and Rec budget. Commissioner Goff expanded upon the necessary repairs and stated the dangers of the downed pole and electrical lines and. Commissioner Daniels made a motion to approve reimbursement to the YMCA for the \$2000, the motion was seconded by Commissioner Golden, with none opposed the motion was approved.

Agenda item #9 – Reducing Speed Limit on Pistole Rd.

Commissioner Daniels brought forth a request to reduce the speed limit on Pistole Rd due to safety concerns from constituents in that district. Commissioner Daniels requested that the speed limit be reduced to 25mph on Pistole Rd. beginning at Burgess Falls Rd. and ending at Howell Cemetery Rd. This request would also include reducing the speed limit to 35mph on Pistole Rd. beginning at Howell Cemetery Rd. and ending at Bunker Hill Rd. A motion was made by Commissioner Golden to send a Resolution to reduce the speed limit to 25mph to the full legislative body, the motion was seconded by Commissioner Margeson. With none opposed, the motion was approved.

Agenda item #10 – Closure of Alex Slatten Trail

Vice Chairman Hutchings brought before the committee a Petition for Road Closure of Alex Slatten Trail submitted by Clinton Busbee. The request was to close Alex Slatten Trail beginning at Indian Mound Rd. and ending at Cedar Creek Rd. in Dist. # 6 of White County. Several citizens from Dist. 6 were present and three (3) of them voiced their strong opposition to the closure, another citizen whose residence is near Alex Slatten Trail, voiced his support for closing the road due to excessive looting, littering and criminal activity that occurs in that area. Road Superintendent, Jerry Sawyer was asked if Alex Slatten Trail was being maintained by the county Hwy Dept. Sawyer stated that it had not been kept up in approximately 10 years and was uncertain as to why. Sawyer further stated that after his review of the road conditions, he estimated the cost to be approximately \$10,000 to repair and make upgrades to Alex Slatten Trail. Commissioner Daniels made a motion to send the matter to the WC Planning Commission for further discussion, motion was seconded by Commissioner Golden, with none opposed the motion was approved.

Agenda item #11 – Agricultural Program Using County Property at Hwy 70 Fields

Executive Robinson informed members of Steering Committee A that he had received some phone calls requesting that the White County High School / Agricultural Program be allowed to use some of the property located at Hwy 70 for educational purposes. Robinson stated that the Director of Schools had not contacted him or made an official request. Dewayne Howard, School Board member was present and was asked for additional details. Mr. Howard stated his

support of the county and school board collaborating on agricultural projects. Howard further stated that the White County School Board was set to meet Thursday evening, October 6, 2022 where he intended to bring the matter before them for discussion. Howard stated that, if approved by the members of the school board and director of schools, they would request an official meeting to discuss the matter in more detail at a later date. No action was taken by Steering A Committee.

Agenda item #12 - Old Business

There was no old business brought before the committee.

Agenda item #13 – New Business

Vice Chairman Hutchings opened the floor for New Business by introducing Officer Nate Theiss, who requested to speak on behalf of Sheriff Page who was not present. Officer Theiss stated that Sherriff Page would like to officially request authorization to sale county owned property. Currently, the White Co. Sherriff Dept. is authorized to sale seized property without approval from the county commission, however, county owned property requires approval from the White County Legislative Body prior to sale. Executive Robinson requested that the matter be tabled until he {Robinson} could consult with legal authorities who could advise the commission if this would be allowed under the 81 Act that White County must abide by. No further action was taken.

In other business, Executive Robinson reminded committee members that according to White County Government Bylaws, Steering Committee A will need to appoint members to serve on the Parks & Recreation Sub-Committee and the Building Committee. Vice Chairman Hutchings requested that these matters be included as Agenda items for the next Steering A meeting.

The White County Steering Committee B met on October 3rd, 2022, at the White County Courthouse. **Members of Committee B include Commissioners Roger Mason, Chairman, Dakota White, V. Chairman, Jordan Cocke, Secretary, Chris Brewington, David Cranford, Robert McCormick, and Kyle Goff.**

Former Steering B Chairman, Kyle Goff called the meeting to order and requested roll call. Members present included, Roger Mason, Dakota White, Jordan Cocke, Chris Brewington, David Cranford, Robert McCormick, and Kyle Goff. Also present was Financial Director, Chad Marcum, and Executive Assistant Brooke Luna. There being a quorum the meeting was called to order. Prayer was led by Commissioner Mason.

Approval of June 6th Steering A Report

Commissioner Goff asked for review and approval of the Minutes from the June 6th, 2022, meeting. With no discussion, Dakota White made a motion to approve the Minutes as presented and Commissioner McCormick seconded the motion; with no objections the motion was approved.

Election of Chairman

Commissioner Goff opened the floor for nominations for Chairman. Commissioner McCormick nominated Commissioner Mason. With no other nominations, Commissioner McCormick made a motion that all nominations cease and Commissioner Mason be elected by acclamation, seconded by Commissioner Cocke; with none opposed the motion was approved.

Election of Vice Chairman

Chairman Mason opened the floor for nominations of Vice Chairman. Commissioner McCormick nominated Commissioner White. With no other nominations, Commissioner Goff made a motion that all nominations cease and Commissioner White be elected by acclamation, seconded by Commissioner McCormick; with none opposed the motion was approved.

Election of Secretary

Letter from Circuit Court Clerk

Chairman Mason read the letter from the Circuit Court Clerk to the committee. The letter stated that there has been a need for storage for documents that she is required to keep indefinitely. There is concern for the building that the stored files are kept in at this time, this building is not fire proof, has electrical issues, and there is no more room to store files that are awaiting to be stored. Finance Director Marcum, stated that this has been an ongoing problem for a lot of departments within the county but clerk's storage was the most significant in size. Mr. Marcum

also stated that this letter needed to be spread on the minutes. Commissioner White made a motion to spread the letter on the minutes of the next County Commission meeting, seconded by Commissioner Brewington; with no objections the motion was approved.

Approval of Agreement with iWORQ Software

Chairman Mason opened the floor for discussion on the iWORQ software agreement. Mr. Marcum shared with the committee the details of the agreement. After reviewing and discussing the agreement, Commissioner Goff made a motion to send approval to Full Court, seconded by Commissioner Cranford; with no objections, the motion was approved.

Ben Lomand Franchise Agreement

Chairman Mason opened the floor for discussion on the Franchise Agreement with Volunteer Wireless (d.b.a. BLTV). Mr. Marcum shared with the committee the details of this agreement he also stated this agreement had a term of 15 years and White County would receive a 3% of their revenue per quarter. With no other discussion, Commissioner White made a motion to send approval to Full Court, seconded by Commissioner Goff; with no objections, the motion was approved.

Surplus Vehicle & Equipment

Chairman Mason opened the floor for discussion on surplus vehicle & equipment. Mr. Marcum stated all items on the list is from the Sheriff's Department and need approval of the commission to surplus. The White County Solid Waste committee met Monday, October 3rd, 2022 at the White County Courthouse. **Members of Solid Waste Committee are Commissioners Dakota White, TK Austin, Becky Golden, Jordan Cocke, Chris Brewington, Derrick Hutchings, and Larry Daniels.**

Executive Robinson called the meeting to order and requested roll call of committee members. Present were Commissioners, Dakota White Becky Golden, Jordan Cocke, Chris Brewington, Derrick Hutchings, and Larry Daniels. Absent was Commissioner TK Austin. Also, present was County Executive, Denny W. Robinson, Solid Waste Interim Director, Bruce Null, Administrative Assistant, Ashlyn Hanna, & Finance Director, Chad Marcum. Present from the community were several other members from the community. There being a quorum, the meeting was called to order.

Approval of August 1st, 2022 Report

Executive Robinson opened the floor for discussion and approval of the Minutes from the August 1st, 2022 Solid Waste meeting. With no other discussion, Commissioner White made a motion and Commissioner Daniels seconded the motion to approve the Minutes as presented. With no objections the motion was approved.

Election of Chairman

Executive Robinson opened the floor for nominations for Chairman. Commissioner Hutchings nominated Commissioner T.K. Austin. With no other nominations, Commissioner Golden made a motion that all nominations cease and Commissioner Austin be elected by acclamation, seconded by Commissioner Cocke; with none opposed the motion was approved.

Election of Vice Chairman

Executive Robinson opened the floor for nominations of Vice Chairman. Commissioner Daniels nominated Commissioner White. With no other nominations, Commissioner Cocke made a motion that all nominations cease and Commissioner White be elected by acclamation, seconded by Commissioner Hutchings; with none opposed the motion was approved.

Election of Secretary

Vice Chairman White opened the floor for nominations of Secretary. Commissioner Hutchings nominated Commissioner Cocke. With no other nominations, Commissioner Golden made a motion that all nominations cease and Commissioner Cocke be elected by acclamation, seconded by Commissioner Brewington; with none opposed the motion was approved.

Engineer's Report

Commissioner White opened the floor to Executive Robinson for the Engineer's report. TriAD submitted supplemental hydrogeologic information to TDEC on September 14, 2022, based on the August 25, 2022, TDEC meeting at the landfill. The supplemental information included a revised seasonal high-water potentiometric surface map. A letter justifying the seasonal high-water elevations was also provided detailing TriAD's hydrogeologic investigation activities at the site and the extensive borrow excavations that have not encountered water at the TDEC presumed elevations. Justification was also provided that adequate hydrogeologic characterization has been performed in the western portion of the proposed landfill expansion area through ECE's hydrogeologic investigation, TriAD's hydrogeologic investigation, and ongoing soil borrow excavation activities. We are currently awaiting TDEC's response. TriAD is coordinating with Tracy

Daugherty with the TDEC Division of Water Resources to verify the extent of the previously identified wetlands within the proposed landfill expansion area. After the engineer's report was given, Executive Robinson addressed questions from the audience and no further business was discussed.

Discussion on Resolution 67-09-2022

Commissioner White opened the floor for discussion on Resolution 67-09-2022. Commissioner Hutchings stated that he requested this resolution to be sent by to the committee for discussion because the resolution was contingent upon a contract with an outside company. Hutchings stated that he would like for the wording of the resolution to leave out the verbiage of "contingent upon a contract with an outside company" so that the county had the ability to take out of county trash regardless. Commissioner Mason stated for clarification that we are not under any pressure at this time to make this decision of taking out of county Class I trash at the landfill. Executive Robinson stated that the language in the resolution needed to state clearly that this only pertains to the landfill and it would exclude out of county trash being accepted at the convenience centers. He also suggested making it contingent upon permitting of the new cell being opened. Hutchings made a motion to send this resolution to full court with the language stating the county would take out of county trash at the landfill only contingent upon permitting of the new cell, seconded by Commissioner Daniels. After some discussion, Daniels withdrew his second and Hutchings withdrew his motion. Hutchings then made a motion to accept out of county trash from municipalities only at the landfill for a fee contingent upon the new cell being permitted and opened; seconded by Daniels; with no other discussion the motion was approved.

AFS Recycling by Clark Lindsey

Commissioner White introduced Clark Lindsey from American Fiber Services Recycling (AFS) and gave him the floor to speak. Mr. Lindsey shared with the committee that AFS Recycling is plastic and paper brokers. They provide equipment and finance that through the sale of the recyclables. Lindsey recommended starting with cardboard and perhaps number one & two plastics. He shared price comparisons for the recycling equipment and how plastics have to be separated and it requires more man power due to the sorting of the type of plastic to bring in a higher revenue. Lindsey answered questions from audience members. There was also discussion on putting the recycling bins back out at the convenience centers but no action was taken.

Old Business: There was none.

New Business

Commissioner White opened the floor for any new business. Commissioner Hutchings suggested that he would like the committee to reevaluate the revenue source for Solid Waste. Hutchings referenced the report sent to him by the Finance Director. Hutchings shared when solid waste fees and charges were last updated. White suggested taking home and reevaluating and studying the reports mentioned by Hutchings but no action was taken.

A calendar update was given by Commissioner White. The next full court meeting would be Monday, October 17th, 2022 at 6 pm and the next Solid Waste Meeting would be November 7th following the Steering A Committee Meeting which starts at 5:30.

Commissioner Hutchings asked Solid Waste Director, Bruce Null if there were any updates, he had for the Solid Waste Committee regarding the landfill. Null shared with the committee the status of equipment repair needs and discussed and answered questions and concerns from the commissioners and members of the audience; however, no action was taken at this time.

There being no further business, Commissioner Golden made a motion to adjourn, seconded by Commissioner Brewington; with no objections, the meeting was adjourned at 7:20 pm.

The White County Budget Committee met on Monday, October 3, 2022 following the Solid Waste Committee at the White County Courthouse. Members present were Mr. Kyle Goff, Mr. Denny Wayne Robinson, Mr. Dakota White, and Mr. Robert McCormick. Also present were Mr. Chad Marcum, Ms. Becky Golden, and Mr. Jerry Sawyer. Absent was Mr. TK Austin

There being a quorum present, the meeting was called to order by Mr. Robinson.

Mr. Robinson asked for approval of the minutes from the August 1, 2022 meeting. Mr. White made a motion and Mr. Goff seconded the motion to approve the minutes as presented. On a voice vote, the motion was unanimously approved.

Mr. Robinson opened the floor for nominations for Chairman. Mr. White nominated Mr. Robinson. Mr. Goff made a motion and Mr. White seconded the motion that all nominations cease and Mr. Robinson be elected by acclamation. On a voice vote, the motion was unanimously approved.

Mr. Robinson opened the floor for nominations for Vice Chairman. Mr. White nominated Mr. Goff. Mr. McCormick made a motion and Mr. White seconded the motion that all nominations cease and Mr. Goff be elected by acclamation. On a voice vote, the motion was unanimously approved.

Mr. Robinson opened the floor for nominations for Secretary. Mr. White nominated Mr. Austin. Mr. Goff made a motion and Mr. White seconded the motion that all nominations cease and Mr. White be elected by acclamation. On a voice vote, the motion was unanimously approved.

The committee considered a Solid Waste Disposal Fund amendment in the amount of \$800,000 to receive and appropriate and nonreciprocal interfund transfer-in from the County General Fund. Mr. Goff made a motion and Mr. White seconded the motion to approve the amendment as presented and recommend its passage by the full county commission. On a voice vote, the motion was unanimously approved.

Mr. Robinson exited to attend another required meeting, leaving Mr. Goff to assume the role of chair.

The committee considered seven (7) General Fund amendments as follows:

1. Justice Center - \$743,600 for a Confined Facilities Grant
2. Sheriff's Department - \$79,200 for TN Dangerous Drug Task Force Funding
3. Sheriff's Department - \$38,851 for a Mental Health Transport Grant
4. Sheriff's Department - \$8,000 for a Federal Bullet Proof Vest Grant
5. Sheriff's Department - \$1,425 received from the sale of surplus vehicles
6. EMA - \$5,050 to appropriate donations from MTNG, Cattlemen's Assoc., and Farm Bureau
