

The White County Steering Committee A met on Monday, May 6, 2019, at the White County Courthouse. Members present were Cain Rogers, Lanny Selby, Dillard Quick, Terry Alley, Lee Broyles, and Bobby McCulley. Absent was Lonnie Crouch. Also present were Denny Wayne Robinson, Chad Marcum, and Gaylen Barlow.

There being a quorum present, the meeting was called to order by Chairman Cain Rogers and prayer was led by Lanny Selby.

Cain Rogers asked for approval of the minutes from the previous meeting. Lanny Selby made a motion and Lee Broyles seconded the motion to approve the minutes as presented. The motion was approved.

Res 00 06 1029 Authorization to Levy Additional Sales Tax:

Denny Wayne Robinson discussed the details of the resolution. Members discussed having a referendum and the advantages and disadvantages of the resolution. Lee Broyles made a motion and Bobby McCulley seconded the motion to send the resolution to full court and have a referendum. After members discussed the motion, it was withdrawn. Lee Broyles then made a motion and Bobby McCulley seconded the motion to send the resolution to full court and have a referendum during the presidential primary. A roll call vote was conducted and resulted as follows: Cain Rogers-no; Lanny Selby-no; Dillard Quick-no; Terry Alley-no; Lee Broyles-yes; Bobby McCulley-yes. The motion failed 4-2.

Discussion of 4-Way Stop at Old Smithville Hwy N. and Corinth Rd.:

Denny Wayne Robinson informed members he had discussed creating the 4-way stop with Highway Superintendent Clay Parker, and he was willing to do so by order of the committee. Terry Alley made a motion and Lanny Selby seconded the motion to send the matter to full court to have the Highway Department set up a 4-way stop at that location. The motion was approved.

Old Business:

Discussion of Fourth of July Celebration:

Denny Wayne Robinson informed members all is going well with the Celebration plans and that the County was willing to help more financially. Mr. Robinson stated a deposit has been paid to the fireworks company and the Celebration is set for July 5 at 4 pm. Lee Broyles advised the baseball leagues are going to help with parking and would need more gravel for the lot.

Cain Rogers informed members the tennis court repairs are being made and should be completed by the end of June. Mr. Robinson stated the County had a good plan with the school system and were working together. Denny Wayne Robinson advised members that planning is done for the County by Highlands Planning Department and that Kevin Rush was the Planning Director. Mr. Robinson stated the County's cost was over \$30,000 per year for Mr. Rush's salary. Mr. Robinson further stated he had been approached by Upper Cumberland Development District who made an offer to do the job for half what the County is paying now. He also discussed possibly reorganizing the Planning Commission. Terry Alley made a motion and Bobby McCulley seconded the motion to send to full court to enter into an agreement with UCDD as approved by the Planning Commission. The motion was approved.

The White County Steering Committee B met on Monday, June 3rd, 2019, at the White County Courthouse. Members present were Andy Haston, TK Austin, Robert McCormick, and Roger Mason. Also present were Finance Director Chad Marcum, Landfill Director Gaylon Barlow and Executive Denny Robinson. Absent was Stanley Neal, Dale Bennett, and Dakota White.

There being a quorum present, the meeting was called to order by Commissioner Robert McCormick.

Commissioner McCormick asked for approval of the minutes from the previous meeting. Commissioner Austin made a motion and Commissioner Mason seconded the motion to approve the minutes as presented. The motion was approved.

Res 00 06 2019 Authorization to Levy Additional Sales Tax

Executive Robinson opened the discussion regarding the Sales Tax Levy. Mr. Robinson reminded the committee that if they wanted to proceed at least one committee would need to send the resolution to full court for a vote. He went on to say that the pros and cons on the Sales Tax option were previously discussed during the joint work session however Mr. Robinson did review the information for those commissioners that did not attend the work session. A concern that has been raised out in the county was the fact that if the County did not choose to "opt in" then only the citizens of Sparta would be voting for the Sales Tax that would affect the entire county. If the Sales Tax is going to be on a referendum, then the citizens of the county would like a voice. Another concern was that the Sales Tax is a tax increase, and there are several citizens who do not like tax increases.

Mr. Robinson went on to explain that if the County "opted out" allowing the citizens of Sparta to vote initially, the County would have the opportunity to see the referendum results before deciding if the County should "opt in" especially since the City of Sparta has tried increasing the Sales Tax previously. It was noted that a Sales Tax Levy has gained popularity in the city. It was further noted that if the City of Sparta did pass the Sales Tax Levy and the County did not, the revenue would solely remain in the City. If the County passed the referendum, the revenue would be divided between the City and the County as well as the School System.

It was the consensus of the committee that the County should have the opportunity to vote on a County wide referendum. Commissioner Roger Mason made a motion and Commissioner TK Austin seconded the motion to send to full court a resolution authorizing a County Wide Referendum to vote on the Sales Tax Levy during the Presidential Primary in 2020. On a voice call vote, all members voted in favor, the motion passed.

Res 00 06 2019 Tri County RR Grant Match

Finance Director, Chad Marcum discussed a resolution authorizing White County to contribute up to \$80,000 to the Tri-County Railroad Authority as a 10% match for Tennessee Department of Transportation (TDOT) Railroad Authority Grant Funds. This resolution stems from the release of \$5 Million in short line railroad rehabilitation funds which were sequestered by TDOT beginning in 2014. TDOT sequestered the funds in response to a lawsuit filed by class I railroad companies which alleged that the tax paid on diesel fuel, which funded the short line railroad rehabilitation program, was discriminatory. After several years of litigation and appeals, the State of Tennessee was victorious in its defense of the tax. In light of this victory, TDOT has released the funds to the various short line railroads in the state, including the \$5 Million to the Tri-County Railroad Authority. However, unlike prior to the sequestration, TDOT is now requiring a 10% match of the funds and has given the Authority 4 years to expend the \$5 Million in funding. The Authority has asked each of the counties which they serve, White, Warren, and Coffee, to each contribute \$20,000 per year for 4 years. The Authority has itself agreed to contribute provide \$100,000 in matching funds, and then ask the operator, Caney Fork & Western, to provide the remaining amount of \$160,000. The railroad serves an important role in economic activity for the entire area and is an important asset to support.

Following the discussion, Commissioner Mason made a motion and Commissioner Austin seconded the motion to send to full court the Tri County RR Grant Match. On a voice call vote, all members voted in favor. The motion passed.

Commissioner McCormick asked the committee for any old business:

Executive Robinson addressed the committee regarding property maintenance codes as it pertains to health and safety. He briefly discussed our planning commission regulations as they pertain to lots 5 acres or less. He suggested that initially our property maintenance codes follow those guidelines as closely as possible. Mr. Robinson stated most of the complaints he receives are on property that is 5 acres or less. The committee briefly discussed the enforcement mechanism and funding. Mr. Robinson stated he would put a packet together to present to the committee.

Commissioner McCormick asked the committee for any new business:

Executive Robinson addressed the committee regarding Courthouse Security/Safety. He stated if there was no opposition, he would contact a consultant for a site visit and proposal regarding courthouse safety. There were no objections from the committee.

There being no further business, Commissioner Mason made a motion and Commissioner Austin seconded the motion to adjourn. The motion was approved.

The White County Solid Waste Committee met on Monday, June 3rd, 2019 immediately following Steering Committee B at the White County Courthouse. Members present were Andy Haston, Robert McCormick, TK Austin, and Roger Mason. Also present were Finance Director Chad Marcum, Landfill Director Gaylon Barlow and County Executive Denny Robinson. Absent was Dale Bennett, Dakota White and Stanley Neal.

There being a quorum present, the meeting was called to order by Vice-Chairman Robert McCormick. Mr. McCormick asked for approval of the minutes from the previous meeting. Commissioner Mason made a motion and Commissioner Haston seconded the motion to approve the minutes as presented. The motion was approved.

Directors Report:

Director Barlow updated the committee on the progress being made by Wright Brothers in regards to the Sump Construction. Mr. Barlow stated that the construction is moving along nicely. Wright Brothers have ordered the man hole, however it will take a couple of weeks to receive. He further states that things are going well in general at the landfill.

Engineer's Report:

Executive Robinson updated the committee on the hydrogeological testing and the results from that testing. The water table is higher than anticipated which will directly impact the life of the new cell. At this point, it is anticipated that the 40 year life expectancy of the new cell could be reduced to 20 years as a direct result of the high water table. In addition, the water is pressurized. Mr. Robinson did specify that this would not deter us from moving forward as planned to permit a new cell.

Mr. Robinson did briefly discuss the sump construction. While digging out an area for the Sump, Wright Brother's indicated that the working area is 80% dirt as oppose to trash. Mr. Robinson and Wright Brother's will be investigating the option of digging out a larger area to gain more air space in our current class 1 cell.

Mr. Robinson updated the committee on the survey from Class 3. TriAD Engineers believe we could apply for a vertical expansion. They have also indicated since that debris decays, we could remove dirt from pervious decay and gain more air space. They indicate we have at least 10 more years and possibly more based on future practices.

Vice-Chairman McCormick asked the committee for any old business:

Director Barlow address the committee regarding the old Mac Front-End Truck. Specifically he wanted to know how the committee felt about keeping the truck as a back-up or if they preferred to sell the truck. Mr. Barlow stated it would take less than a \$1,000.00 for some needed repairs such as brakes and air conditioning. It has approximately 150,000 miles, which is relatively low mileage for that type of truck and does have a rust issue with the body and bed of the truck. Other than that, Mr. Barlow feels it would be a good back-up truck. After a brief discussion, it was the consensus of the committee to keep the truck.

Vice-Chairman McCormick asked the committee for any new business:

There was none.

There being no further business, Commissioner Mason made a motion and Commissioner Haston seconded the motion to adjourn. The motion was approved.

A RESOLUTION AUTHORIZING WHITE COUNTY TO CONTRIBUTE UP TO EIGHTY THOUSAND DOLLARS (\$80,000.00) TO THE TRI-COUNTY RAILROAD AUTHORITY AS A 10% MATCH FOR T.D.O.T. RAILROAD AUTHORITY GRANT FUNDS

WHEREAS, pursuant to *Tennessee Code Annotated* Section 64-2-301, White County is a member of the Tri-County Railroad Authority which was established to secure economic benefits to Warren County, Coffee County, and White County by providing for the continuation of railroad services in the three counties; and

WHEREAS, the Tennessee Department of Transportation Equity Trust Fund has a portion of funds dedicated to maintain and rehabilitate railroad lines such as those running through Warren County, Coffee County, and White County; and

WHEREAS, that for several years the Tennessee Department of Transportation Equity Trust Fund had a portion of its funding sequestered due to a lawsuit pending against the State of Tennessee and that this funding has recently been released by the State of Tennessee to once again be utilized by local railroad authorities such as the Tri-County Railroad Authority; and

WHEREAS, the Tennessee Department of Transportation has available funds to distribute to the Tri-County Railroad Authority in an amount up to Five Million Dollars (\$5,000,000.00) and requires a ten percent (10%) match from the Tri-County Railroad Authority to receive funds; and

WHEREAS, the Tri-County Railroad Authority is requesting that White County contribute to the Tri-County Railroad Authority the amount of Twenty Thousand Dollars (\$20,000.00) per year for four (4) years for a total contribution of Eighty Thousand Dollars (\$80,000.00) in order to gain the maximum contribution available from the Tennessee Department of Transportation Equity Trust Fund; and

WHEREAS, the annual contribution made by White County, Tennessee shall be retained by the Tri-County Railroad Authority only if matched by Warren County, Tennessee, and by Coffee County, Tennessee.

WHEREAS, the railroad lines running through White County, Tennessee are of major importance to the economic health of White County and that the contribution to the Tri-County Railroad Authority would secure the continued operation of the railroad lines.

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of White County, Tennessee, meeting in regular session on this the 20th day of May, 2019, as follows:

SECTION 1: That the governing body of White County, Tennessee is authorized to support the Tri-County Railroad Authority by making an annual contribution in an amount not to exceed Twenty Thousand Dollars (\$20,000.00) per year for the next four (4) years for a total contribution not to exceed Eighty Thousand Dollars (\$80,000.00).

SECTION 2: That the County Executive of White County, Tennessee is hereby authorized to enter into a contract with the Tri-County Railroad Authority agreeing that White County, Tennessee's annual contribution will be made each year only in an amount equal to that of the contributions made by Warren County, Tennessee and Coffee County, Tennessee.

SECTION 3: That this resolution shall take effect from and after its passage, the welfare of the County requiring it.

Section 3. The Department of Revenue of the State of Tennessee shall collect the additional tax imposed by this resolution concurrent with the collection of the state tax and the local tax being collected for White County, in accordance with rules and regulations promulgated by the Department.

Section 4. Suits for the recovery of any tax illegally assessed or collected shall be brought against the State Commissioner of Revenue and the White County Executive.

Section 5. A certified copy of this resolution shall be transmitted to the Department of Revenue by the County Clerk forthwith and shall be published one time in a newspaper of general circulation in White County prior to the March 3rd, 2020 Sales & Use Tax Referendum called for in Section 2.

BE IT FURTHER RESOLVED that the budget for the School Federal Projects Fund shall be the budget approved for separate projects within the fund by the Tennessee Department of Education and the White County Board of Education. Budget amendments shall be approved by the White County Board of Education and the Budget Committee of the White County Legislative Body.

SECTION 2. BE IT FURTHER RESOLVED that there are also hereby appropriated certain portions of the commissions and fees for collecting taxes and licenses and for administering other funds which the trustee, county clerk, circuit court clerk, clerk and master, register, and the sheriff and their officially authorized deputies and assistants may be entitled to receive under state laws heretofore or hereafter enacted. Expenditures out of commissions and/or fees collected by the trustee, county clerk, circuit court clerk, clerk and master, register, and sheriff may be made for such purposes and in such amounts as may be authorized by existing law or by valid order of any court having power to make such appropriations. Any excess commissions and/or fees collected over and above the expenditures duly and conclusively authorized shall be paid over to the trustee and converted into the General Fund as provided by law.

BE IT FURTER RESOLVED that if any fee officials, as enumerated in Section 8-22-101, Tennessee Code Annotated, operate under provisions of Section 8-22-104, Tennessee Code Annotated, provisions of the preceding paragraph shall not apply to those particular officials.

SECTION 3. BE IT FURTHER RESOLVED that any amendment to the budget, except for amendments to the budget for funds under the supervision of the director of schools, shall be approved as provided in Section 5-9-407, Tennessee Code Annotated. The director of schools must receive approval of the Board of Education for transfers within each major category of the budget, and approval of both the Board of Education and the Board of County Commissioners for transfers between major categories as required by law.

One copy of each amendment shall be filed with the county clerk, one copy with the chairman of the Budget Committee, and one copy with the each divisional or department head concerned. The reason(s) for each transfer shall be clearly stated; however, this section shall in no case whatsoever be construed as authorizing transfers from one fund to another, but shall solely apply to transfers within a certain fund.

SECTION 4. BE IT FURTHER RESOLVED that any appropriations made by this resolution which cover the same purpose for which a specific appropriation is made by statute is made in lieu of but not in addition to, said statutory appropriation. The salary, wages, or remuneration of each officer, employee, or agent of the county shall not be in excess of the amounts authorized by existing law or as set forth in the estimate of expenditures which accompanies this resolution. Provided, however, that appropriations for such salaries, wages, or other remuneration hereby authorized shall in no case be construed as permitting expenditures for any office, agency, institution, division, or department of the county in excess of the appropriations made herein for such office, agency, institution, division, or department of the county. Such appropriation shall constitute the limit to the expenditures of any office, agency, institution, division, or department for the year ending June 30, 2020. The aggregate expenditures for any item of appropriation shall in no instance be more than the amount herein appropriated for such item.

SECTION 5. BE IT FURTHER RESOLVED that any resolution which may hereafter be presented to the Board of County Commissioners providing for appropriations in addition to those made by this Budget Appropriation Resolution shall specifically provide sufficient revenue or other funds actually to be provided during the year in which the expenditure is to be made to meet such additional appropriation. Said appropriating resolution shall be submitted to and approved by the state director of Local Finance after its adoption as provided by Section 9-21-403, Tennessee Code Annotated.

SECTION 6. BE IT FURTHER RESOLVED that the county executive and county clerk are hereby authorized to borrow money on revenue anticipation notes, provided such notes are first approved by the state director of Local Finance, to pay for the expenses herein authorized until the taxes and other revenue for the year 2019-2020 have been collected. The proceeds of loans for each individual fund shall not exceed 60% of the appropriations of each fund and shall be used only to pay expenses and other requirements of the fund for which the loan is made. The loan shall be paid out of revenue from the fund for which money is borrowed. The notes shall be signed by the county executive and countersigned by the county clerk and shall mature and be paid in full without renewal not later than June 30, 2020.

SECTION 7. BE IT FURTHER RESOLVED that the delinquent county property taxes for the year 2018 and prior years and the interest and penalty thereon collected during the year ending June 30, 2020, shall be apportioned to the various county funds according to the subdivision of the tax levy for the year 2018. The clerk and master and the trustee are hereby authorized and directed to make such apportionment accordingly.

SECTION 8. BE IT FURTHER RESOLVED that all unencumbered balances of appropriations remaining at the end of the year shall lapse and be of no further effect at the end of the year at June 30, 2020.

SECTION 9. BE IT FURTHER RESOLVED that the compensation of County Commissioners shall be an equal amount of Two Hundred, Fifty dollars per month based upon the amount budgeted beginning July 1, 2019.

- 4. That prior to disbursement being made to any of the above named nonprofit charitable or civic organizations that the county executive shall be entitled to a financial statement from the nonprofit charitable or civic organization.
