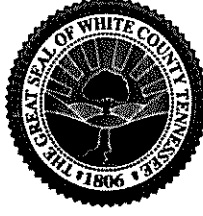

The White County Steering Committee A met on Monday, January 12, 2015 at 5:30pm at the White County Courthouse. Members present Mr. Dale Bennett, Mr. Harold England, Mr. Russell Gooch, Mr. Terry Alley, Mrs. Diana Haston, and Mr. Mack Johnson. Others present was Mike Sparks and Stephanie Smith from the animal shelter; Mark Billbrey and Silas Hatmaker with the Doyle Softball League. Absent was Mr. Jack Sherrell. There being a quorum present, the meeting was called to order by Mr. Bennett and prayer was led by Mr. Gooch.

Mr. Bennett asked for approval of the minutes from the previous meeting. Mr. England made a motion and Mrs. Haston seconded the motion to approve the minutes as presented. The motion was approved.

The committee discussed the needs of the animal shelter with Mr. Sparks and Mrs. Smith. It was reported that signs have been purchased and will be going up soon. It was also stated that the animal shelters food supply is enough to get the shelter by until the new budget. Having monies left in the budget for "Animal Food and Supplies" (line item 401) Mr. Gooch made a motion and Mr. England seconded the motion to move the remainder of these funds to "Other Supplies and Materials" (line item 499) making these funds available for the purchase of security cameras and some other items that the shelter has requested. Motion was approved. It was also mentioned that they may be able to get some of the inmates to help with some of the work at the shelter and that Mr. Sparks would need to speak to James Jones with the Litter Control Department.

Old Business:

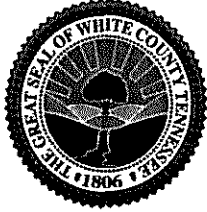
recreation. Committee A has requested Mr. Marcum to see what he can find out on this and report back to the committee.

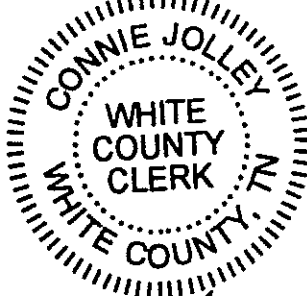

Motion made by Stanley Neal and seconded by Harold England that the above resolution be adopted.

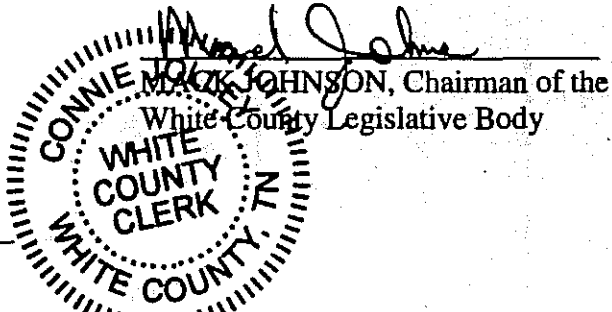

A RESOLUTION TO APPLY TO THE TENNESSEE DEPARTMENT OF
TRANSPORTATION FOR COMMUNITY TRANSPORTATION PLANNING GRANT

WHEREAS, City of Sparta, Tennessee, is eligible for grant funds under the Community Transportation Planning Grant Program administered by the Tennessee Department of Transportation; and

WHEREAS, City of Sparta, Tennessee, is eligible for a minimum grant of two hundred fifty thousand dollars (\$250,000.00) under the Community Transportation Planning Grant Program; and

WHEREAS, the total cost of the project is broken down as follows:

1. Community Transportation Planning Grant Program	<u>\$225,000</u>
2. White County	<u>\$25,000</u>
TOTAL	<u>\$250,000</u>

WHEREAS, White County has agreed to pay the ten percent (10%) required to match their grant amount received to complete this project.

NOW, THEREFORE BE IT RESOLVED, by the White County Commission that:

1. The County Executive be authorized and directed to:
 - A. Execute and submit an application for Community Transportation Planning Grant Program funds to the Tennessee Department of Transportation in order to provide a Bicycle Master Plan.
 - B. Enter into the necessary agreements with the Tennessee Department of Transportation to receive and administer said grant funds.
 - C. Execute necessary agreements for engineering services without further action by the County Commission, contingent upon approval by the funding agencies.

2. The Upper Cumberland Development District shall prepare all necessary documents for the completion of said application for the proposed project at no charge to White County.

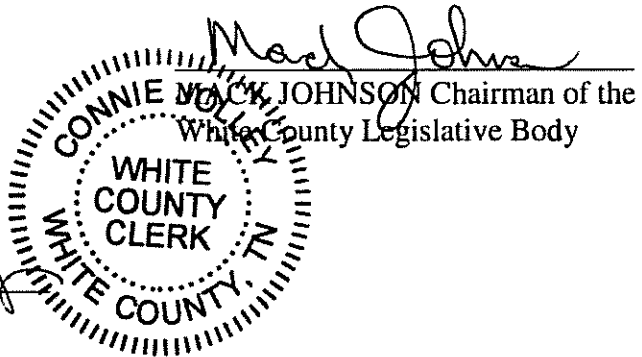

Thank you for your participation in the Safe Dams Act. On September 30, 2013, personnel of this Division conducted a Safety Inspection on the above referenced dam. Based on this inspection, the dam appears to comply with the Safe Dams Act, TCA 69-11-101 et seq., and therefore merits a Certificate of Approval and Safety for operation. Enclosed is an inspection report, which outlines the observed conditions at this dam.

During the inspection, certain minor conditions listed below were observed. These conditions need to be corrected or monitored to insure they do not develop into a serious threat to the safety of the dam.

1. **The seepage from both abutments and along the downstream toe shall be monitored regularly and notify this office of any significant changes in flow rate and turbidity.**
2. **A routine maintenance program on the dam shall be continued.**

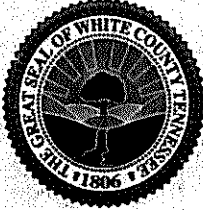

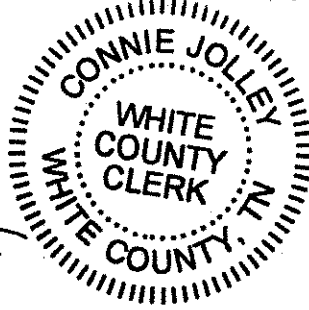
